I respond in connection with your request for information dated 08/04/2011 which was received by the Metropolitan Police Service (MPS) on 08/04/2011. I note you seek access to the following information:

1. With whom at the News of the World, and where, did Andy Hayman have dinner on April 25 2006?
2. What employees of News Group Newspapers were present at the dinner Andy Hayman attended on April 25 2006?
3. Who attended the dinner from the Metropolitan Police that Andy Hayman attended on April 25 2006?
4. Who paid for the dinner that Andy Hayman attended on April 25 2006?
5. What was the cost of the dinner that Andy Hayman attended on April 25 2006?
6. Please send me the original invitation for this event and copy of acceptance.
7. Please tell me whether permission for Andy Hayman to attend was sought from the Commissioner given the Metropolitan Police's pending phone hacking investigation.

I understand that under the Act, I should be entitled to a response within 20 working days of your receipt of this email.

Some parts of this request may be easier to answer than others. Should this prove to be the case, I would ask that you release available data as soon as possible - rather than hold up the entire request.

I would prefer to receive this information electronically.

If the decision is made to withhold some of this data using exemptions within the Act, please inform me of that fact and cite the exemptions used.

If you need any clarification then please contact me at the number below or via email.

Under your section 18 duty to provide advice and assistance I would expect you to contact me if you find this request unmanageable in any way. I would be grateful if you could confirm that you have received this request, and I look forward to hearing from you in the near future.

#### EXTENT OF SEARCHES TO LOCATE INFORMATION

Following receipt of your request, searches were made of the Gifts & Hospitality register in use during Mr Hayman's tenure as Assistant Commissioner Specialist Operations.

An entry in this register records a gift or hospitality from an external party or parties.

it is therefore implicit that the News of the World hosted the dinner and consequently the cost would be unknown to the MPS.

Not all of the requested information would have been recorded in the Gifts & Hospitality register.
