Virgin Atlantic investigates 'secret tip-offs' to paparazzi

Exclusive Airline official resigns after email reveals celebrities' flight times

A senior employee at Virgin Atlantic has resigned after allegations that she passed private flight details of celebrities, including Ashley Cole and Slenna Miller, to a global paparazzi agency.

Emails seen by the Guardian indicate that a Virgin Atlantic supervisor of Upper Class customers passed detailed flight information of at least eight celebrities to the London-based firm Big Pictures.

The Virgin Atlantic employee, who resigned yesterday after the Guardian raised the claims, appears to have been told in an email from Big Pictures that the agency was "trying to sort you out some money with accounts".

The allegations will intensify scrutiny by politicians and the courts over the alleged illicit trade of private Information by some media companies in the UK. Solicitors for Cole and Miller, two of those named in the email, said last night they were taking legal instructions over the alleged leak.

The email to Big Pictures says: "Got a few more for you!" then lists celebrity flights from London for Miller, Cole, his former wife Cheryl, the Tottenham footballer Jermaine Defoe, actors Scarlett Johansson and Gwyneth Paltrow, and singers Robbie Williams and Nicole Scherzinger.

Sir Richard Branson's Virgin Atlantic said it was taking the apparent leak "extremely seriously" and launched an urgent Inquiry into the affair. The company said in a statement: "The allegations that have been raised are extremely serious and we have launched an immediate investigation.

"The security of customer information is our highest priority and we have robust

"The security of customer information is our highest priority and we have robust processes in place to ensure that passenger information is protected. The incident that has been alleged concerns eight customers' flights booked in 2010 and we are in contact with all of those people. It is too early to draw conclusions on this matter but of course we would deeply regret any concern that these allegations may cause the individuals involved."

The airline employee, who looked after high-profile customers on Virgin Atlantic flights, is understood to have resigned yes-

terday but denies passing the information to Big Pictures. The employee said she was "not going to comment on that at all" and hung up the phone when contacted on

mot going to commention that at all and uning up the phone when contacted on Wednesday morning.

Checks by the Guardian confirm that, where known, the whereabouts of the celebrities matched the details apparently disclosed by the Virgin Atlantic employee.

Cole, the Chelseaand England defender, was pictured at Heathrow by a Big Pictures photographer on the date given in the correct dates. Defoe was reported to be in St Lucla for his children's charity between the dates listed in the email.

Sources at the airline said that four of the eight celebrities flew on the dates given, but the other four cancelled their bookings. The flight codes given in the correspondence – such as VS7 for Heathronida.



10 inquiries into police racism allegations

Scotland Yard was facing fresh questions over the conduct of its officers last night after itrevealed details of seven new complaints of alleged racism which it said it had referred to the police watchdog. Speaking after a week in which the Metropolitan police came under pressure to clamp down on racism in its ranks, the Yard's deputy commissioner, Craig Mackey, said that seven flurther cases had yesterday been referred, or referred again, to the Independent Police Complaints Commission (PEC). The move yester-day takes the total number of complaints under investigation to 10.

Last night the Met confirmed that 20 police officers and one police staff meniber were now under investigation for alleged racist incidents. Of those under investigation, eight police officers and the member of polices taff avenow been suspended, Scotland Yard said last night. At least three other officers have been placed on restricted duties.

Declaring in a statement that there was "no room for racism in the Met", Mackey said the new referrals had been niade as part of a review of racism allegations. All had already been "In the process of being considered" by Scotland Yard, he said, while four complaints had been referred to the IPCG.

A spokeswoman for the IPCC said the watchdog had not yet received the latest referrals and would "assess each case on its merits and make a decision regarding the level of IPCC involvement needed.

Three officers from Newham were already under investigation after reports by the Guardian of cases involving the alleged racist abuse of a 2-year-old black man in the aftermath of the riots.

The seven new complaints made public include allegations of bullying, abuse and physical assault dating back as far as 2010. Claims include:

Racist connuents by another three Newham officers between lanuary and Marchits year.

- Racist comments by another three Newham officers between January and March
- this year.

 © Bullying by a number of police officers and staff against PCSOs over an 18-month period in Wandsworth.

 © An assault involving five officers from the territorial support group against several youngsters in Hyde Park in 2011.

 © A complaint from a member of the pub-



Contacts the key in hunt for the big picture

In an era where anybody with a camera phone can be a paparazzo, the compettion for celebrity pictures is intense. The right exclusive photograph, sold worldwide, can still be worth over £100,000 - but they are hard to come by. To make matters more difficult, the amount that the news media are prepared to pay for pictures is falling, and tabloid picture desks worry increasingly about harassment and intrusion after a succession of adverse judgments. Amid such pressure it is not surprising that such pressure it is not surprising that rs can be cut.

Jeff Moore, the chainnan of the British Press Photographers' Association, recalls working on a photoshoot with the singer Rihanna, at the Corinthia hotel near Trafalgar Square, in London, earlier this year, in which there were "six photographers Inside, and about 25 guys wairing outside trying to get a picture of her leaving".

The waiting photographers are hoping to snatch a shot that will be used by any one of the growing number of celebrity websites - but Moore says that it is a business that "the older guys are being pushed out of" because "there is no money in it".

A simple picture of a star coming out of a hotel might only be worth £30 or £40 on a website. In newspapers, or other print media, it depends on the size of the image, but a modestly sized news photograph could be worth perhapa faso a time - not much given that there will be agency fees to pay for a mostly freedure trade.

will be agency fees to pay for a mostly freelance trade. Odds may improve slightly if you wait outside a London club for a celebrity to

emerge, preferably falling over (the Box club being the new favourite) but the strategy is so obvious that it is hardly worth considering as a fresh way to

worth considering as a fresh way to make a living.

There are plenty of ways of getting an edge, the most obvious being official accreditation, although veteran. snappers complain that having a pass to take photographs at Downing Street has its disadvaintages, because it is cold, even in the middle of summer.

Meanwhile, the owner of Heathrow, BAA, licences a small number of photographers who are allowed to be based alriside, so they can get the first shots of whoever is coming from planes that day. At the same time, the airport owner offers celebrities and well-heeled members of the public the chance to avoid all potential photographers; if they are prepared to pay for the privilege: £1,500 plus VAT.

Just walting around is hardly likely to be productive in a world where exclusivity is the most important commodity. Tip-offs from a network of sources are how any branch of journalism works; celebrity publicists frequently report that hotel or restaurant staff will let photographers know who

may be arriving on any particular night. It is the sort of publicity that venues will often want too. Whatever the competition, the celebrity news business is dominated by a handful of agencies, including Big Pictures, whose founder, Darryn Lyons, below, became well known for his dyed hair and toned abs after appearing on Celebrity Big Brother. On the other hand, there is no short-age of the famous or mildly famous who will work with a photographer in the hope of getting a little extra publicity - which is easier work all round. The celebrity would look for a cut of any image that is sold - demanding anywhere up to 40%, depending on

anywhere up to 40%, depending on the name involved, Some agencies will even pay for D-listers to travel, perhaps as part of a tie-up with a hotel - as evidenced by the number of pictures of The Only Way Is Essex stars in bikinis in Dubai in articles where the venue is inevitably named.

Just knowing somebody is in the country can be critical, and alriports are often good places to start. Publicists report that the most intense car chases happen in Los Angeles, where it is necessary for the biggest stars to hire ex-military drivers and employ a decoy car to avoid the chasing pack.



The agency, which employs 29 members of staff and 152 freelance photographers, paid 553,000 in damages to Miller in November 2008 over harassment and invasion of privacy. Big Pictures also agreed not to photograph the actor in public.

"I don't agree that people should be hounded up and down the street all day in any shape or form," Lyons told the Leveson inquiry.

"But I do agree that people... as a part of history, should be photographed in public places, absolutely, and I'm avid about it. We have a free press and a free press should be able to work in public places."

He added: "We live in a world of voyeurism. It is a business where young people look up to ... 50% of celebrities want to be photographed and they lower it for their own self-gain in terms of financial back pocket, and to make them more famous."

It is very likely that during your involvement with The UNIQ Programme, you will have contact, and deal with some very high profile VAA customers.

This could entail members from Royal Families from the UK or abroad, senior UK and International Government Ministers and MP's, UN Ambassadors, and US Senators and Congressmen. Not forgetting many "A" List Celebrities, and key businessmen and women from influential corporate industries.

The reasons for passenger travel can also vary. Some may involve personal and family related trips, or holiday vacations. While others relate to business commitments and obligations.

Whatever the purpose of their travel arrangements with VAA represents, the CONFIDENTIALITY of their personage, booking details and their UNIQ Form information must be ensured at all times. This includes information placed in the UNIQ Database that may also be subsequently printed for distribution to on-board crew and the global airport networks.

Guarding what you say, where you say it, and to whom, needs to be up most in your mind. This would include the leaving of passengers UNIQ Forms and details in a public, unsafe, or insecure location to prying eyes. Even a minor slip could potentially leave the company's security precautions exposed, and open to Data Protection Act damage claims. Not forgetting the possibility of negative media coverage.

It is recognised, that having contact, and dealing with high profile passengers is interesting and exciting. Nevertheless, please remember that their privacy and all round well-being, is a major part of your responsibility within the UNIQ role. Particularly personal details such as telephone numbers, address's etc. which can be ascertained through the UNIQ Database and customers UNIQ Forms.

It is additionally important not to become involved or add to any "gossip" or "rumour" surrounding UNIQ Passengers' travelling with Virgin Atlantic. Discussions between friends, acquaintances, or even work colleagues, who are not included in the company's "need to know" criteria of the Programme, should be avoided at all times.

Please remember unwarranted information voiced, confirmed or UNIQ Forms just left lying around, is potentially an unnecessary risk.

Your skills, attributes, and capabilities are very much recognised and valued by the company. We are confident, that your involvement within the UNIQ Programme will be highly successfully and enjoyable. Your enthusiasm and expertise ensures that our key clients, receive the full benefits of flying VAA.
