Dear David,

It was very good to see you here at Kingham Hill School recently. I do hope you enjoyed the visit as much as we enjoyed meeting you.

I have two things to ask you:

- a) Firstly, I am hoping to start up a Sixth Form Diners' Club next term, where we have a formal (relative) meal every fortnight to which we invite a guest speaker. Afterwards we would retire to the Sixth Form Bar where the students could chat informally to the speaker. The guest would speak for about 15-20 minutes maximum on a relevant topic of interest to the Sixth Form student, principally on politics, current affairs, business and employment, universities, GAP years etc. I would be very happy to invite you as a guest speaker, perhaps on one of the following dates should they be convenient to you: Friday 16 January, Friday 23 January, Friday 19 March

If none of these dates is available to you I would be happy for you to recommend dates you could make, this is assuming you are happy to speak to the students. As for the topic of a talk, I leave that up to you. Knowing however, that all the students will probably be voting at the next election and University Fees is an issue of the moment for them.....

- b) The other issue concerns publicity and how it can impinge on our students. The ISC and the BSA (Boarding Standards Association) have issued guidance to all schools not to publish photos of students in the press, on web sites etc. if the full names of the students are used as well. This is to prevent approaches to individuals by prospective paedophiles who trawl the media for possible victims. However, it is clear that the Press are not supportive of this advice, and are telling us that they will not now publish any of our pictures or stories as a result of us following the ISC advice. This is impinging on our PR. As an individual school, if we feel the advice is good, there is little effect we can have on the local press. I therefore wondered whether this is an issue that could be discussed in a wider national forum. Could advice to all schools, particularly boarding schools that are more vulnerable, be co-ordinated and communicated?

I would be happy to discuss this matter further with you. As far as I am aware the new National Care Standards' advice mirrors that of the ISC on this matter.
