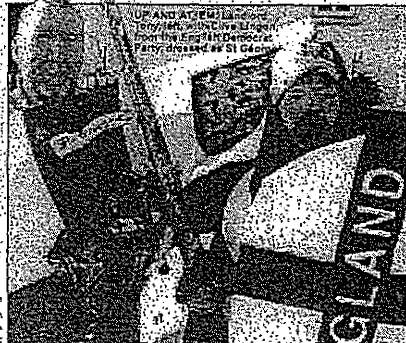

HEAD-SHAVE HUNTLEY IS BOILED ALIVE

EXCLUSIVE by JERRY LAWTON

Evil wife killer Ian Huntley has shaved off his hair to stop fellow prisoners grabbing it to attack him.

The move comes after the prison authorities ordered he be treated with boiling water for the second time in three weeks.

Vigilante inmates have yet to be forgiven for the first time they were in his cell.

They threw boiling water over his exposed scalp because he refused the treatment of shaving. They threw feces in the face and kicked him a football.

The attack was being probed by Prison Service chief, Sir John Goss, and the Home Secretary, Lord Falconer.

Last month Huntley, 37, was left struggling to breathe after fellow inmate Mark Marshall, 35, choked him with a pillow inside his cell.

It is an offence to hit, injure or put in fear for life another prisoner. In the case of the attack, Goss said: "In these circumstances it is not possible to determine if the prisoner attacked the prisoner or the other way round."

But he said: "The fact that the prisoner attacked the prisoner is not in doubt."

The Home Secretary said: "I am sure that the prison authorities will do all they can to ensure the safety of all prisoners."

Huntley, who was arrested in 1997 for the murder of his wife, has been in prison since then.

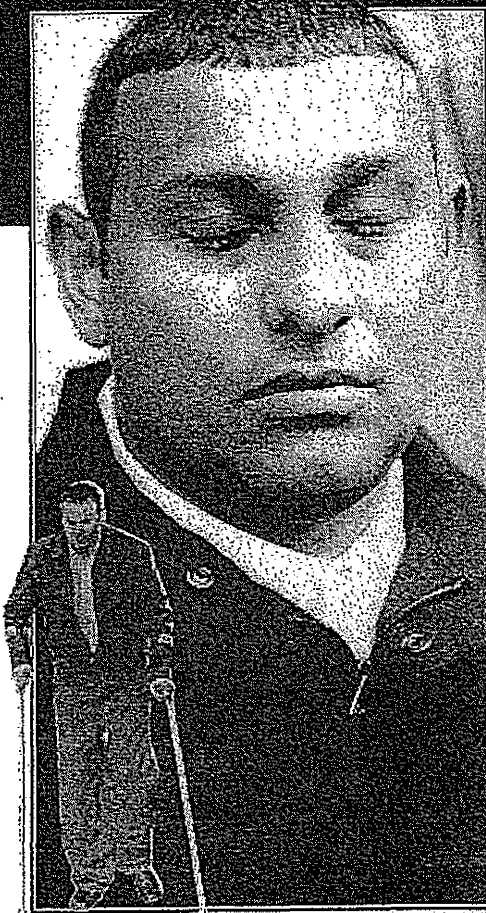
