Baroness Buscombe appointed Chairman of Press Complaints Commission

The Press Standards Board of Finance Ltd (PressBoF), representing the newspaper and magazine publishing industry, announced today that Baroness Peta Buscombe, currently Chief Executive of the Advertising Association, will be the next Chairman of the Press Complaints Commission (PCC). She will succeed Sir Christopher Meyer when he stands down at the end of March 2009. In making the announcement Tim Bowdler, Chairman of PressBoF, said:

Baroness Buscombe said "It is an enormous privilege to be asked to take up the Chairmanship of the PCC. I have always been a champion of self regulation which is vital to balance the freedom of the press with the rights of the public. This is a crucial time in the development of the PCC and I greatly look forward to the challenges ahead."

Sir Christopher Meyer commented that "Peta Buscombe is an excellent choice for the job which is as challenging as it is enjoyable. I have no doubt that she will be highly successful in further strengthening the effectiveness, independence and credibility of the PCC".

Biographical note:

Baroness Buscombe is presently Chief Executive and Director General of the Advertising Association. Trained as a barrister, she has had an extensive career in politics and the private sector. In 1998 she was made a Life Peer and has been a Conservative front bench spokesman in the House of Lords on several briefs including Trade and Industry, Social Security, Legal Affairs, Cabinet Office, Education and Skills, Home Office and Culture, Media and Sport.
